- Applicants must show evidence of successful completion of an N.R.A. handgun-training program and possess a certificate from the MA. State Police or the N.R.A. Other training or experience may be accepted at the discretion of the members present.
- All applicants are voted on by the club members present. Upon election, payment of dues and a \$15.00 application fee must be made. Membership is valid through December 31st of the current year. Dues are prorated semi-annually.
- All members are strongly urged to belong to the N.R.A and G.O.A.L See the N.R.A and G.O.A.L Representative for applications.
- **The use of ammunition containing STEEL or BI-METAL bullet of any brand is prohibited on the indoor range.**
- **This club has a "NO GUEST POLICY." This means that in order to shoot here, membership is required.**

If accepted as a member, I will abide by the by-laws and regulations of the Holyoke Revolver Club. I will also abide by the visitor policy. Visitors may accompany a club member to the property but neither party may shoot or handle firearms during the visit. This includes personal protection guns carried by HRC members. Visitors may observe regularly scheduled matches, events and meetings.
